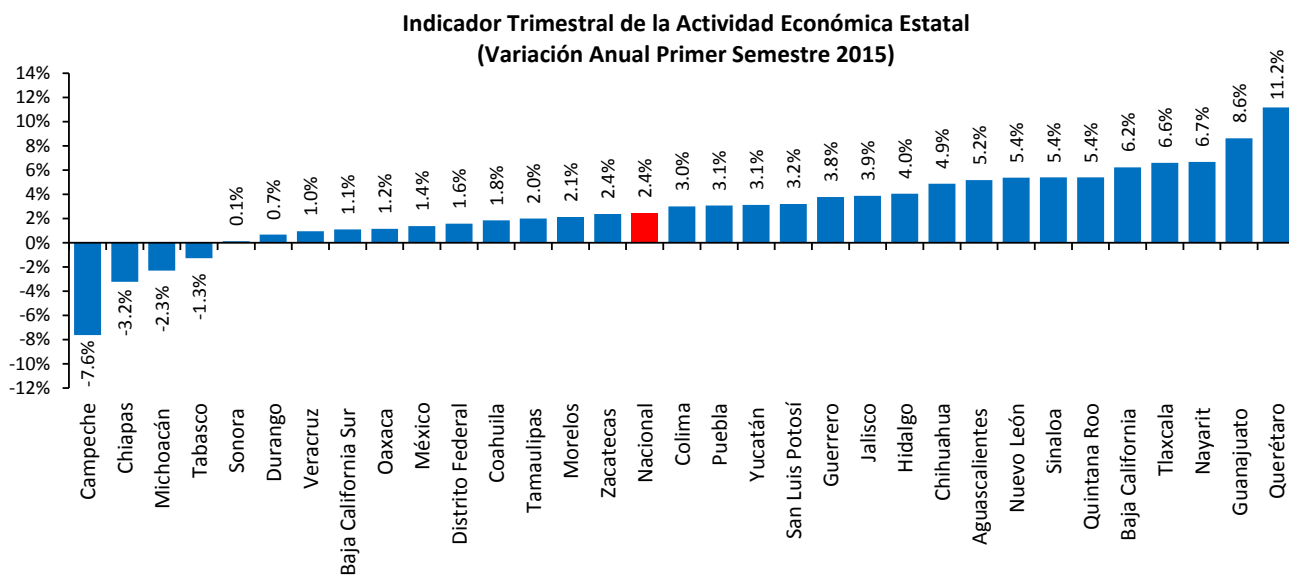

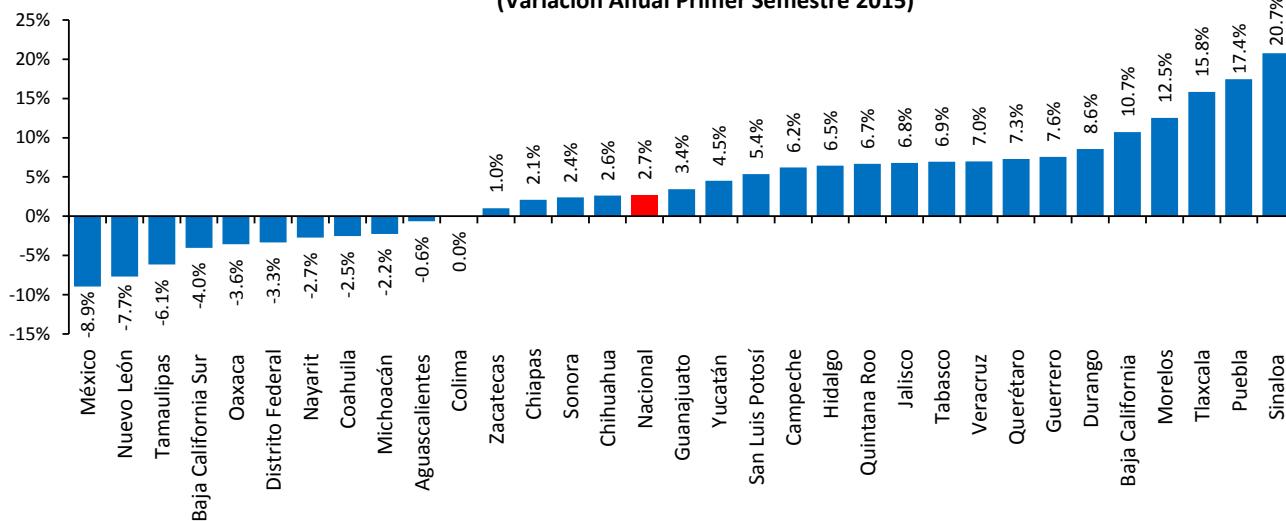

(Variación Anual Primer Semestre 2015)



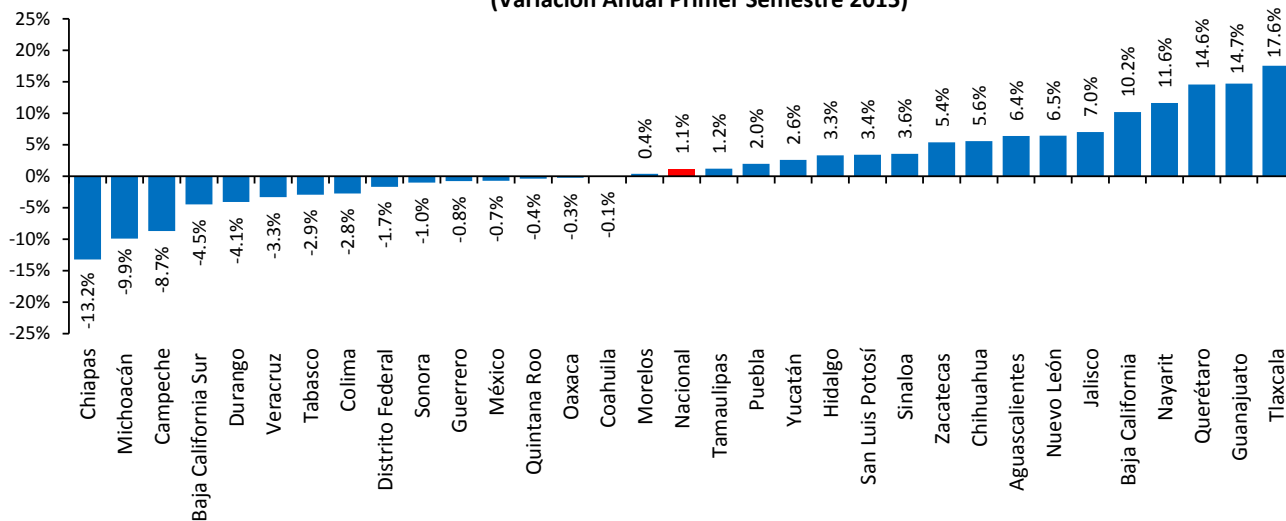

(Variación Anual Primer Semestre 2015)



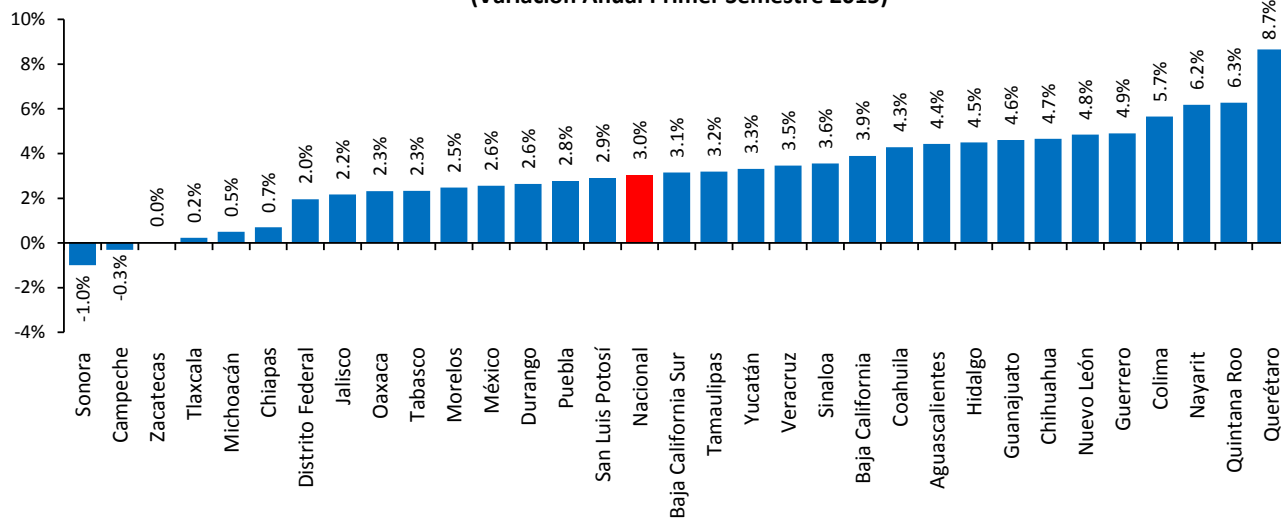

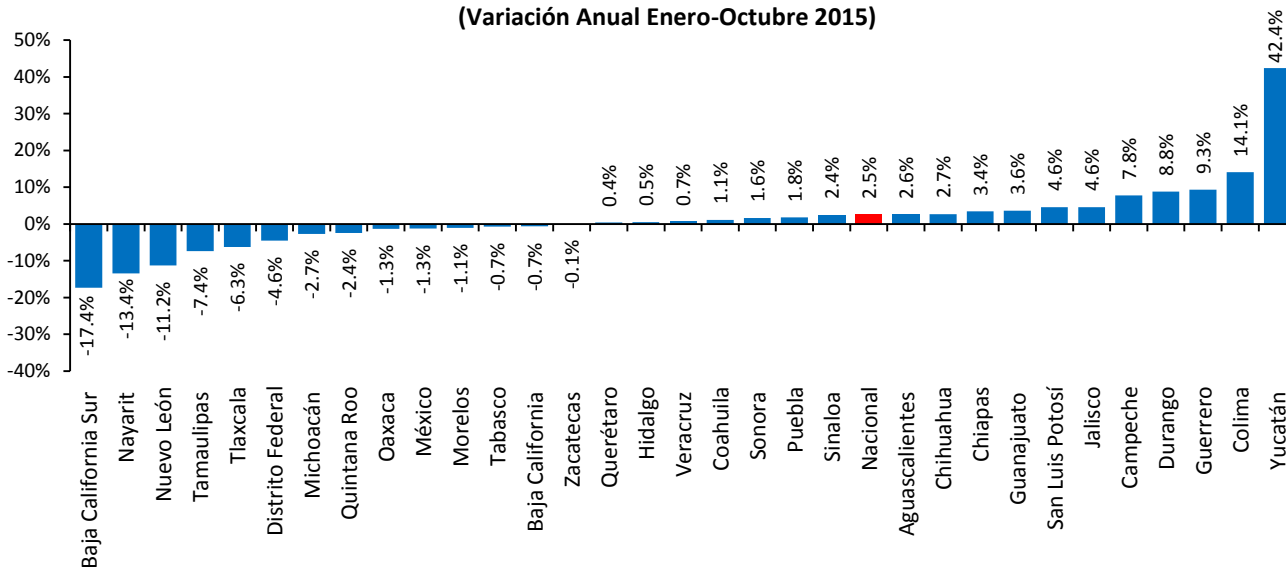

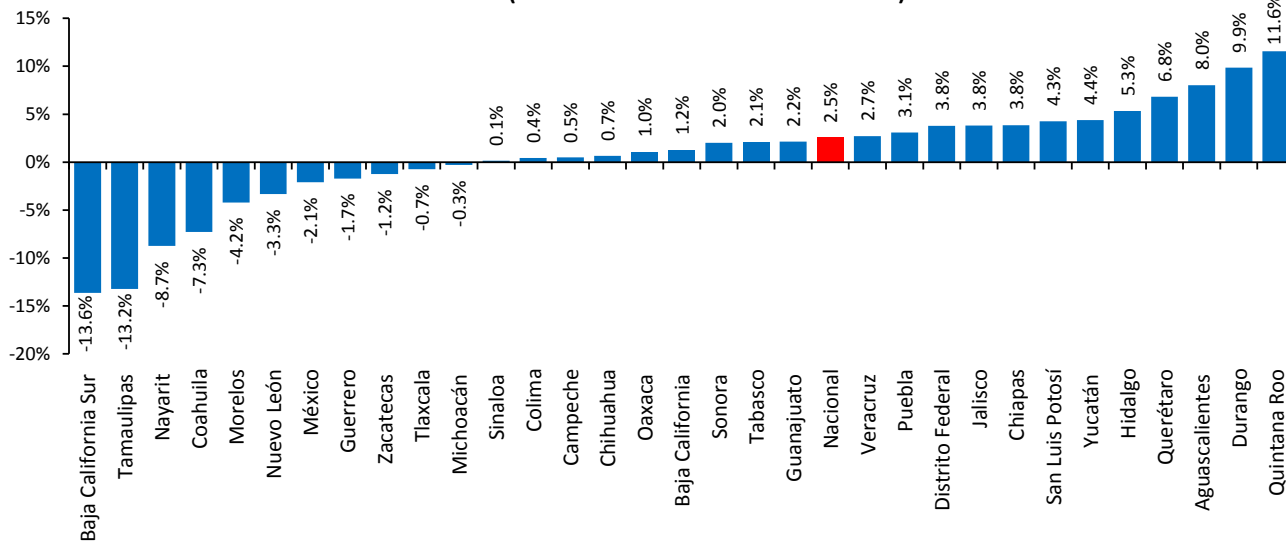

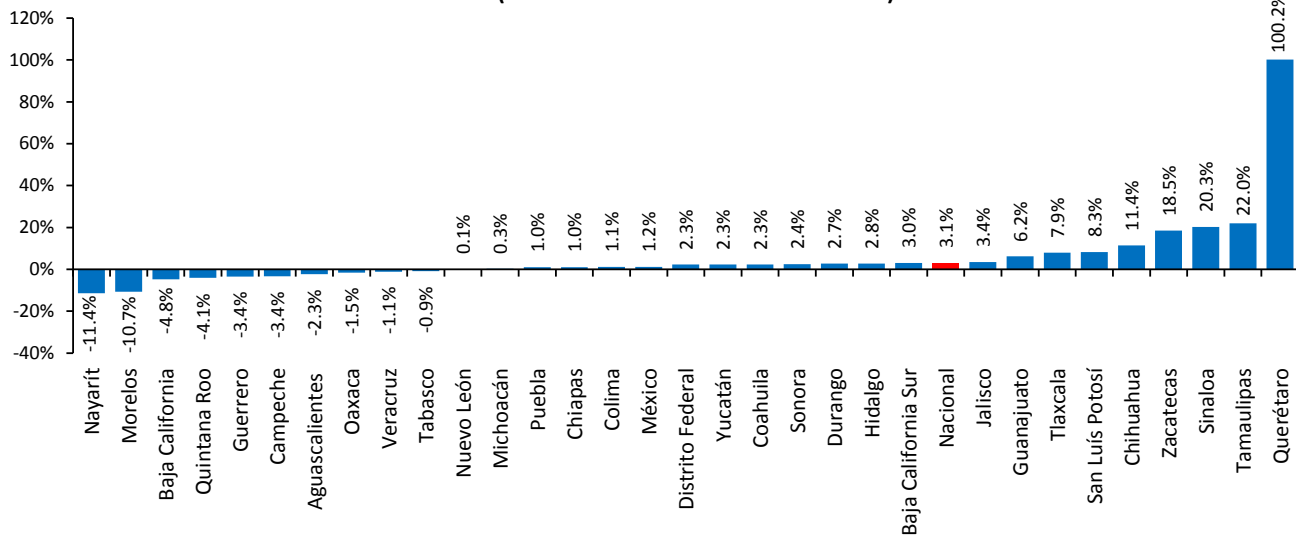

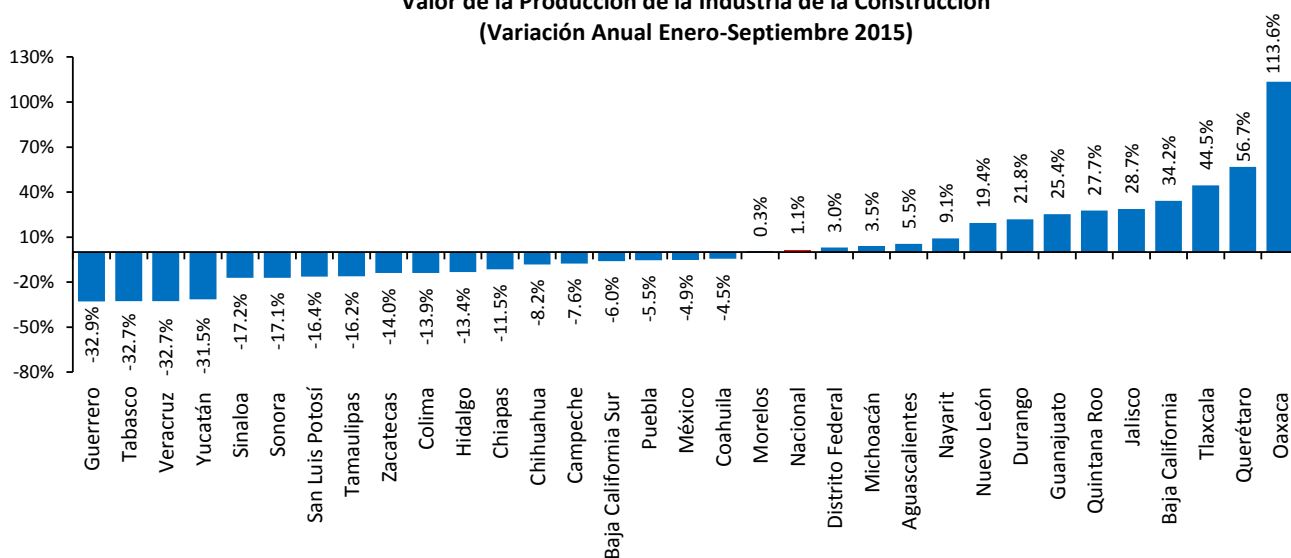

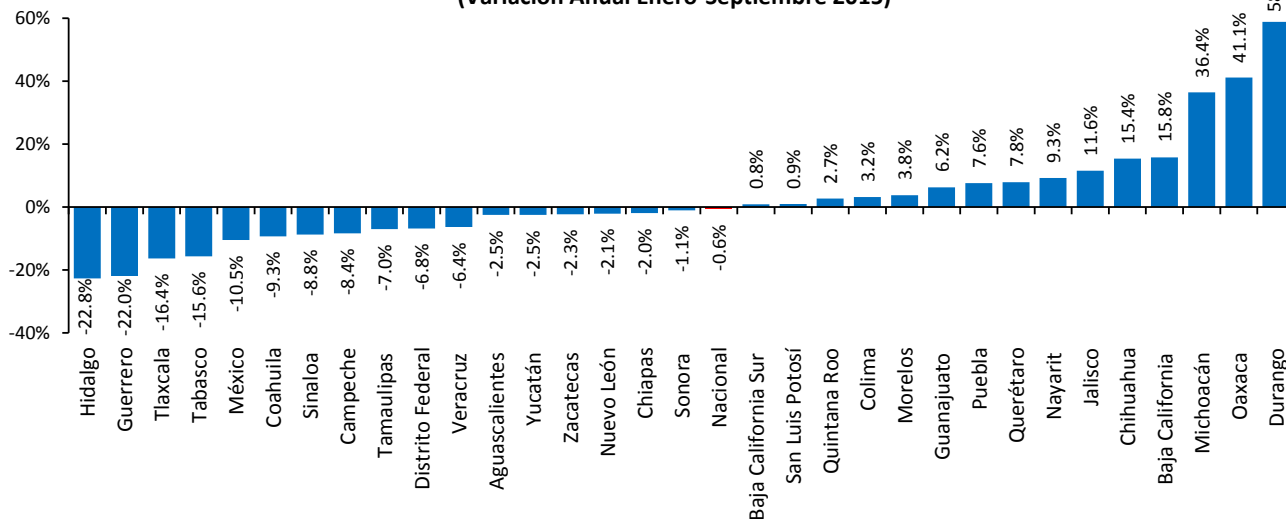

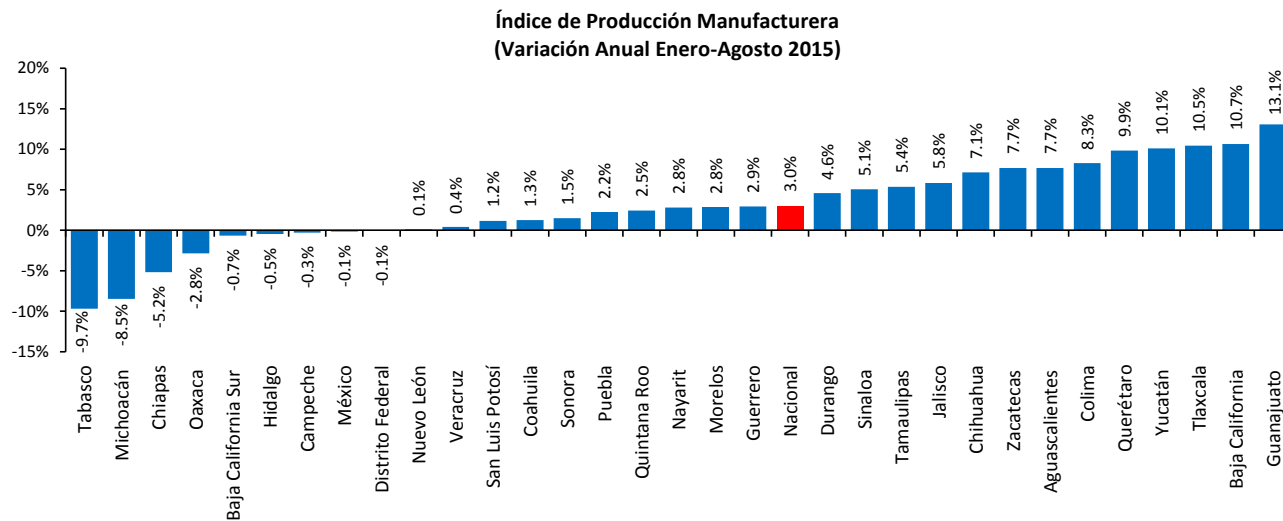

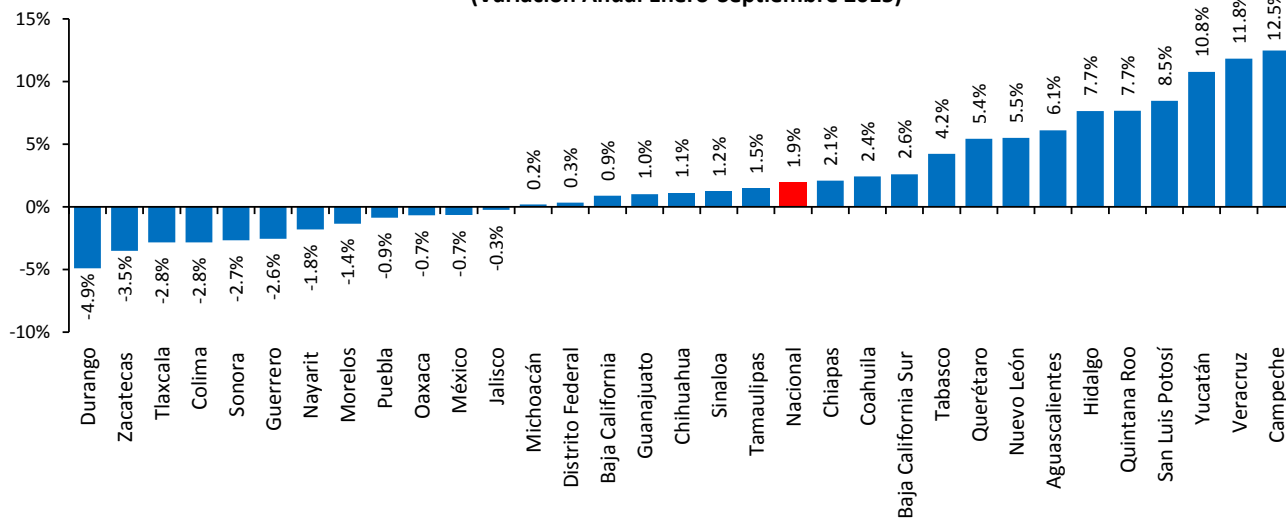

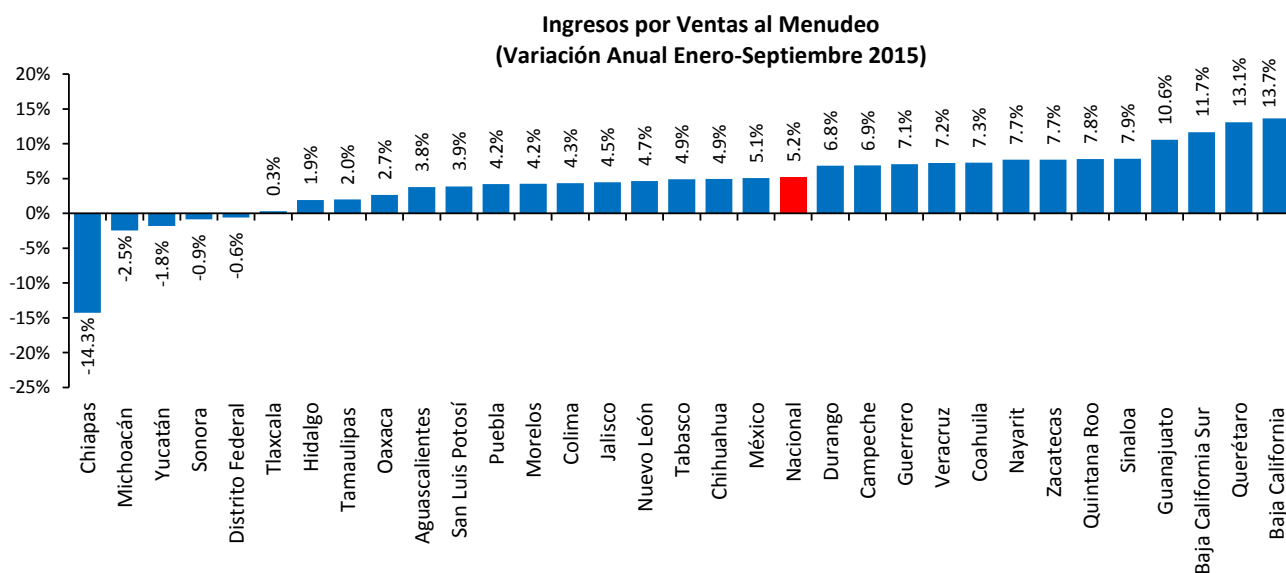

(Variación Anual Enero-Octubre 2015)**

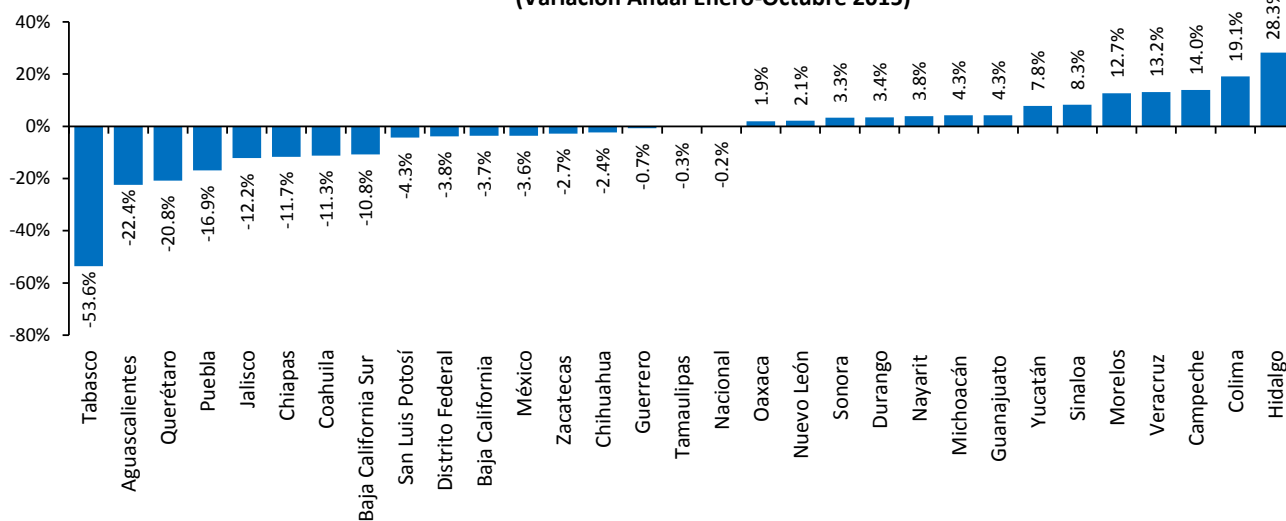

(Variación Anual Enero-October 2015)**

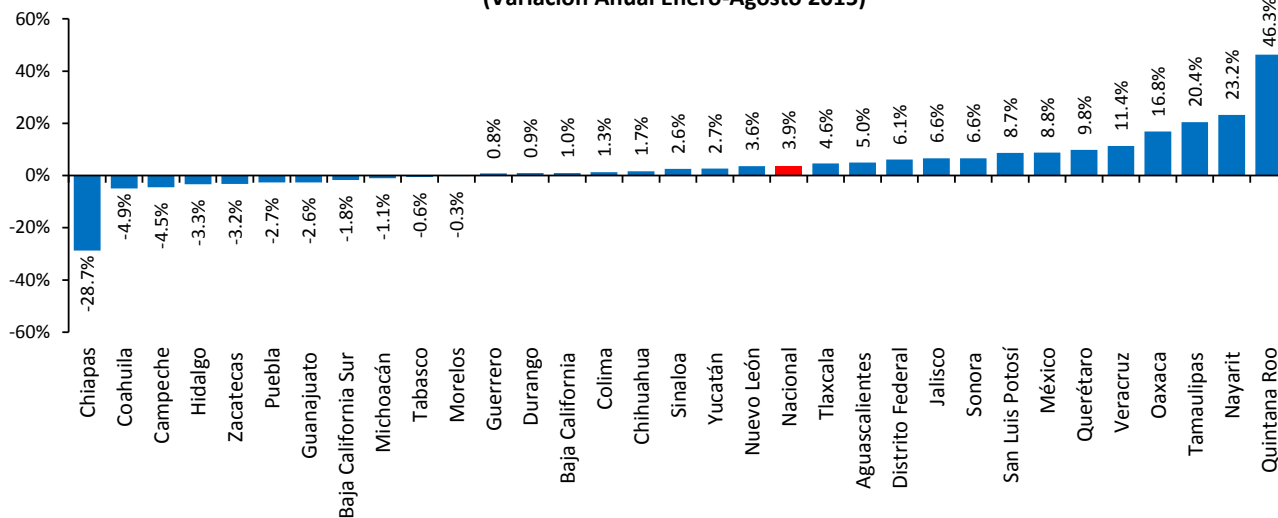

(Variación Anual Enero-Agosto 2015)**

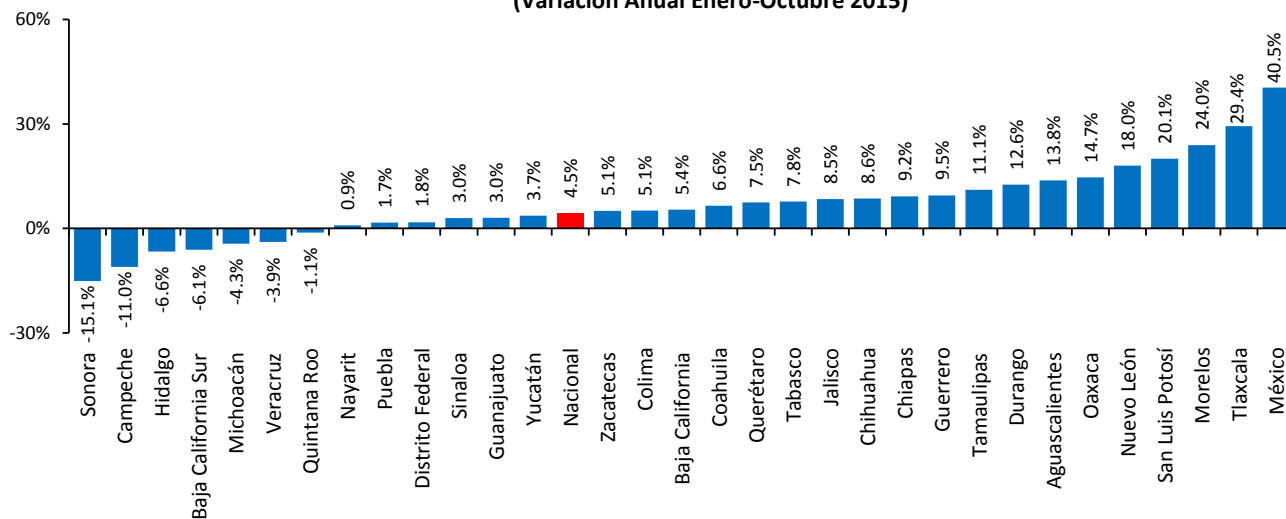

(Variación Anual Enero-October 2015)**

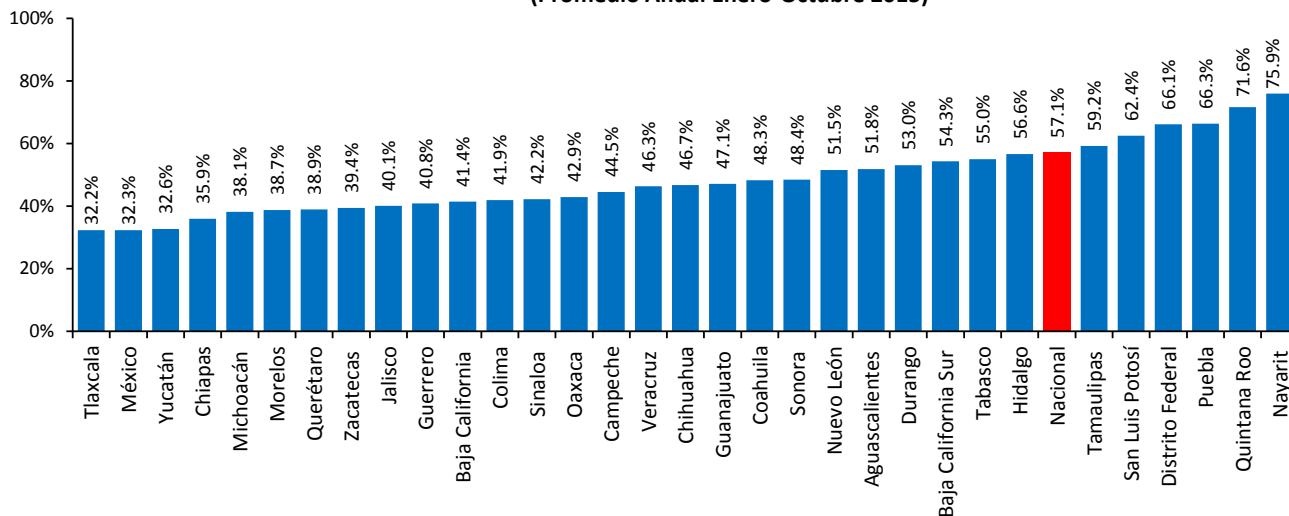

(Promedio Anual Enero-Octubre 2015)**

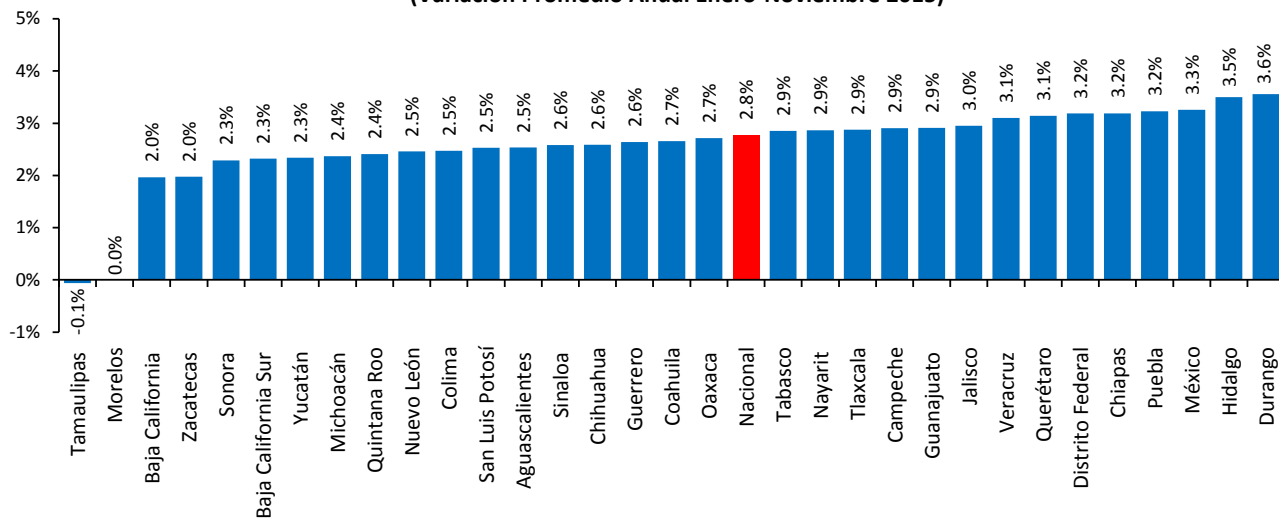

(Variación Promedio Anual Enero-Noviembre 2015)**

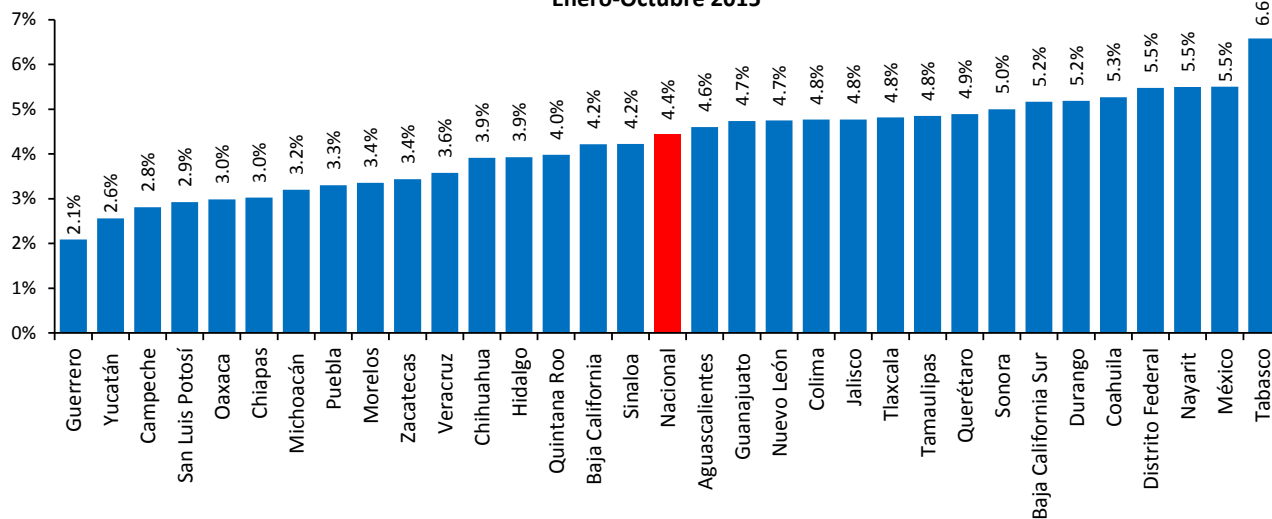

Enero-October 2015

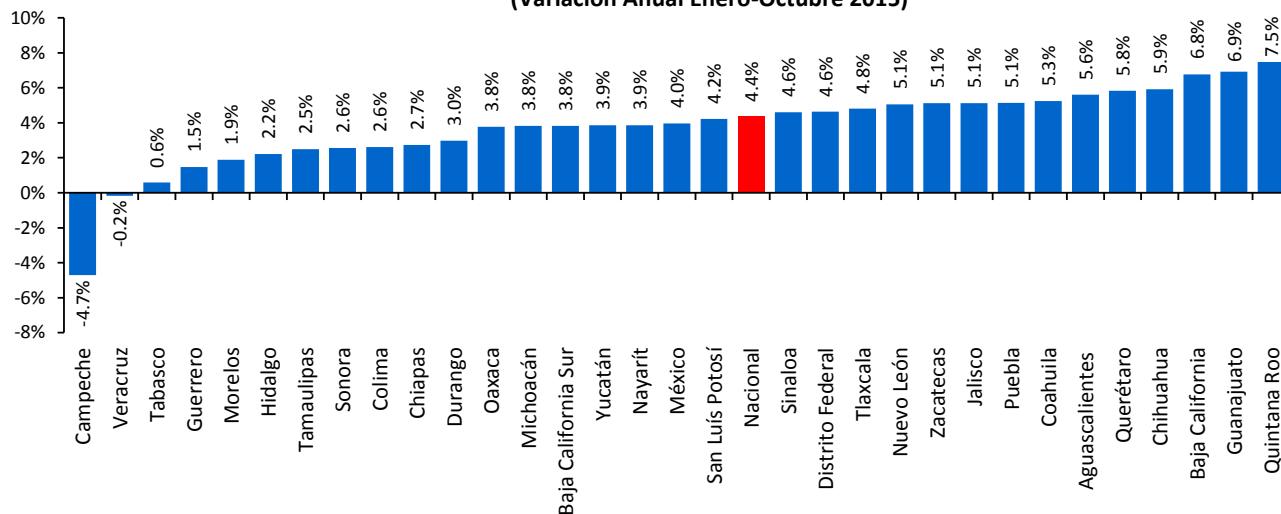

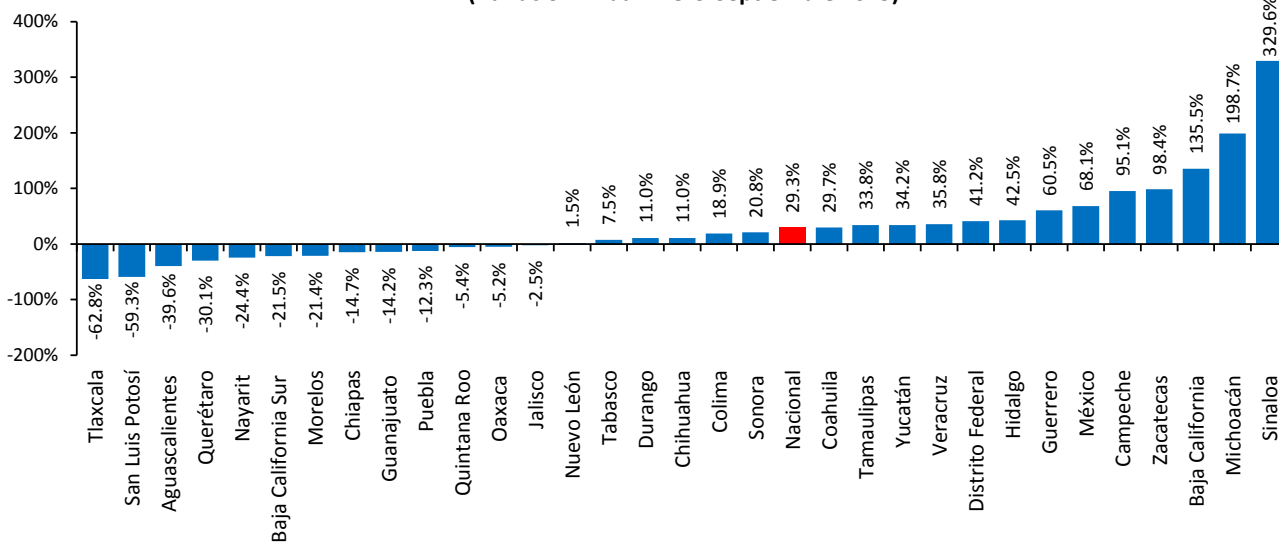

(Variación Anual Enero-Septiembre 2015)**

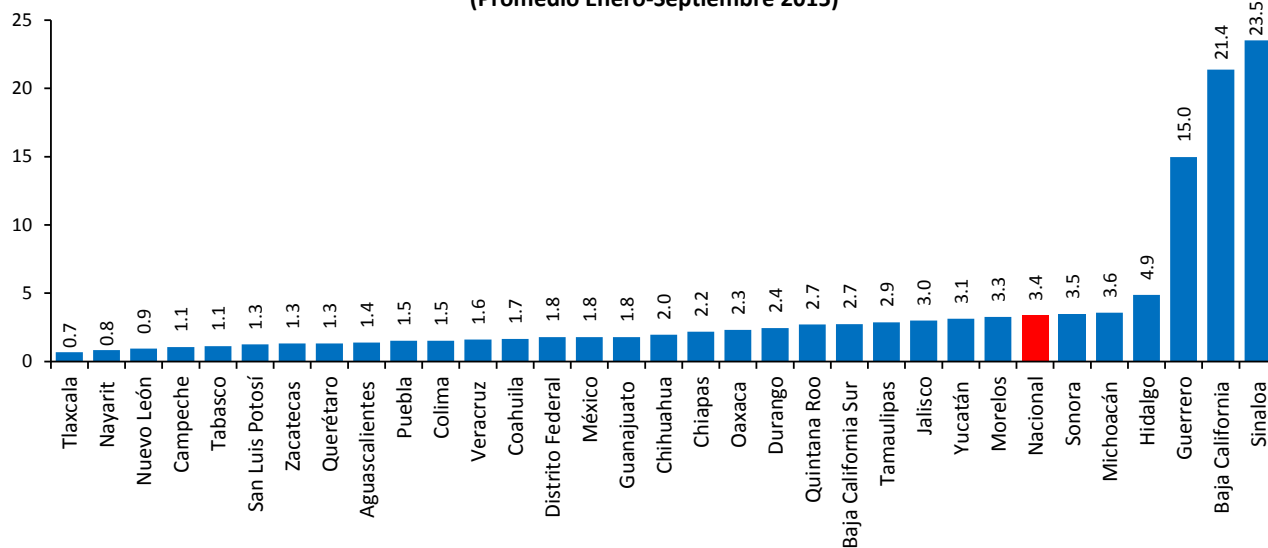

(Promedio Enero-Septiembre 2015)**

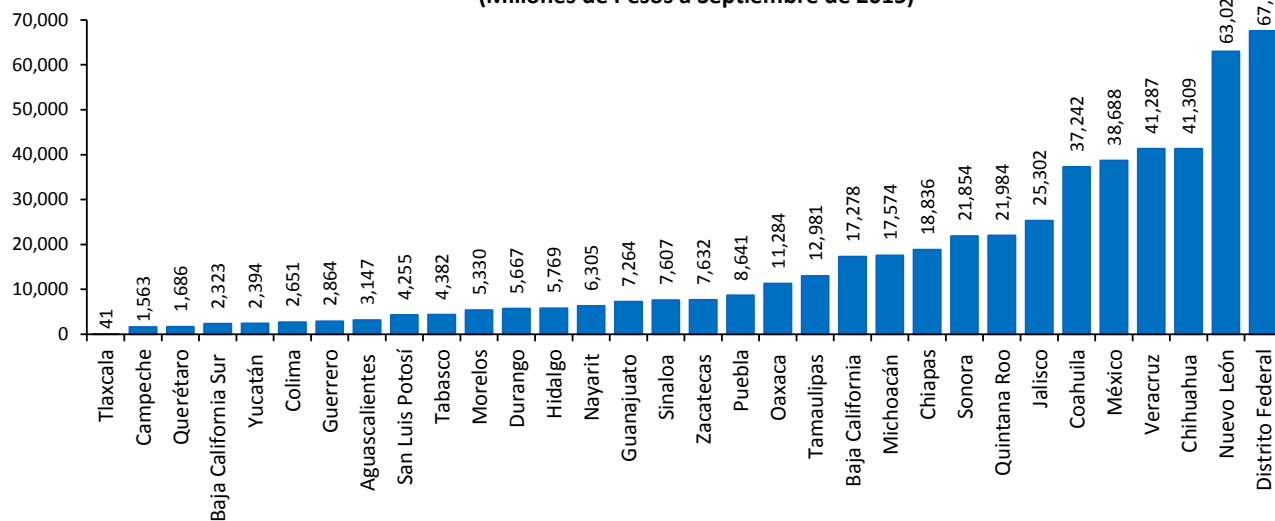

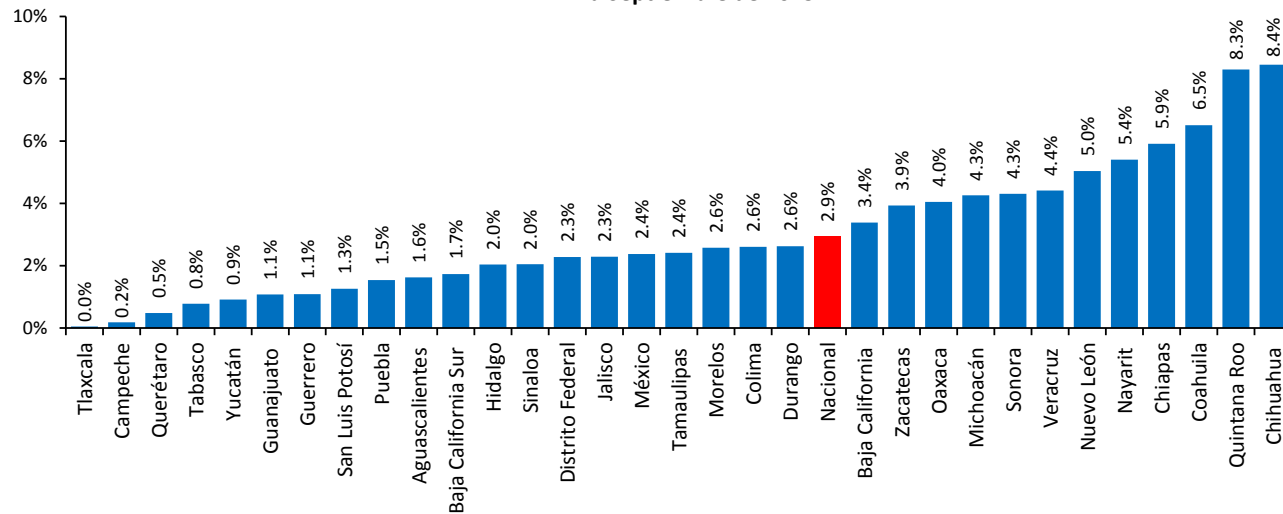
